

# PRIVACY NOTICE:

## Governors, Trustees & Members

Schools within the Equinox Learning Trust (Kennet School, Whitelands Park Primary School and Francis Baily Primary School) are required to hold and process personal data, relating to the Trust's governors, trustees, and members. The Trust acts as the data controller for the purposes of data protection law.

### Personal data we hold about you

We currently collect and process the following information:

- 🔒 your name, address and contact details including email address and telephone numbers
- 🔒 your date of birth
- 🔒 your qualifications, skills, experience, and current employment history
- 🔒 information about your criminal record
- 🔒 photographs and video recordings including CCTV.

### How we collect the information and why we have it

The Trust may collect information in a variety of ways such as through the biography and register of business interests' forms completed by you at the start of your term as a governor, trustee or member; from correspondence with you; or through interviews, meetings or other assessments. The Trust may also collect personal data from criminal records checks permitted by law.

Governance data is essential for the Trust's operational use. Whilst the majority of personal information you provide to us is mandatory, some of it is requested on a voluntary basis. We will inform you at the point of collection whether you are required to provide certain information to us or if you have a choice in this.

Under UK GDPR, the lawful bases we rely on for processing this information are:

**Public Task:** The data is necessary to allow the school to function. It also allows the Trust to build a comprehensive picture of governance and how it is deployed; to enable appropriate checks to be completed, such as an enhanced background and criminal records check from the Disclosure and Barring Service.

Taking photographs and videos of pupils is a key part of life in the Trust's schools. Photographs or videos of pupils used for teaching or welfare purposes may occasionally include images of governors in the background. Examples include recording a lesson to help with pupils' learning or photographs for use in an internal exhibition or display. Your photograph will be used on your identity pass and stored on the secure network.

**Legal Obligation:** In some cases, the Trust needs to process the data to meet the statutory duties placed upon it. For example, details of all governors must be shared with the Department for Education under the requirements set out in the Academies Financial Handbook.

**Legitimate Interest:** It is also within the legitimate interests of the Trust for governors, trustees, and members to be kept informed of governance training and other relevant information to support them in their roles.

**Consent:** The Trust requires your consent to use photographs and videos more publicly to promote the schools through marketing materials, e.g. school displays, school prospectuses, newsletters, the schools' and Trust websites, social media, and other marketing channels. ## Storing information

All data is kept in the statutory book as required by company law. Your photograph is stored on our secured network.

## What we do with the information we have

We do not share information about our governors, trustees or members with anyone without consent unless the law and our policies allow us to do so.

Your information may be shared internally within the Trust, including with the Trust's HR and Administrative teams, and IT staff if access to the data is necessary for the performance of their roles.

The Trust routinely shares information with:

- ❶ the Department for Education (DfE) through Get Information about Schools (GIAS)
- ❷ third party suppliers who support the Trust with its governance
- ❸ School Office - in case of emergency or an Ofsted inspection it is necessary for the school office to hold details of any individual involved in the governance of the school
- ❹ website – the register of business interests will be published on the website in accordance with paragraph 3.1.20 of the Academies Financial Handbook 2015 extant. Alongside this, we publish your name, address, telephone number, email address, photograph and whether you have children attending the Trust's schools and their year groups. This is a closed site, visible to other governors, trustees and members, clerk to the governors, site administrators (including FROG Education who would access the site only if there were an issue) and our IT department
- ❺ Trustees only - in accordance with Section 167 of the Companies Act 2006 Trustees must be registered with Companies House
- ❻ Disclosure and Barring Service - All academy governors, trustees and members are required to have an enhanced criminal record certificate.

This data will be subject to confidentiality arrangements.

## Transferring data internationally

Your data will not be stored or sent outside of the UK.

## Requesting access to your personal data

Under data protection law, you have rights including:

- ❶ **Your right of access:** You have the right to ask us for copies of your personal information.
- ❷ **Your right to rectification:** You have the right to ask us to rectify information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.
- ❸ **Your right to erasure:** You have the right to ask us to erase your personal information in certain circumstances.
- ❹ **Your right to restriction of processing:** You have the right to ask us to restrict the processing of your information in certain circumstances.

- 🕒 **Your right to object to processing:** You have the right to object to the processing of your personal data in certain circumstances.
- 🕒 **Your right to data portability:** You have the right to ask that we transfer the information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we will respond to it within one month of receipt. Please contact us if you wish to make a request: [Data Protection Officer](#).
